Shuttle

Last autumn, we were hopeful of a positive decision on a licence for Malahide Shuttle from the new National Transport Authority (NTA); our optimism was based on statements the NTA had made that they would 'place the consumers' interests at the heart of decision making'. Sadly, this optimism was misplaced; the application was refused on more or less the same grounds as the Department of Transport had refused it last year – protection of Dublin Bus.

We have appealed the refusal and are awaiting the result of this appeal.

Tidy Town

The Tidy Towns group remains very active. Once the construction work has been completed in the railway station, it is planned to re-open the Heritage Garden.

Application has been made to Fingal County Council for numerous wildlife signs and seating benches to be installed in various areas from the western end of the Broadmeadows Estuary out as far as Robswall. The Bee Garden in the Library grounds has been spring-cleaned.

It is planned to run a series of weekly clean-ups around the centre of Malahide and outer areas, commencing in late May on Saturday mornings at 10.00 am, with an anticipated duration of two hours. The gathering spot will be the Ammonite Statue on the Green and further details will be announced later.

Cricket Grounds

The next phase of the expansion of Malahide Cricket Club grounds will take place during late summer and early autumn. This will involve ground works to develop a newly expanded pitch, and a second pitch in order to ensure the club has enough ground capacity for its own fixtures as well as for international matches.

The outline of the second pitch has already been marked out in the Lady's Acre. The timing of the work has been established in order to minimise disruption to the 2011 cricket season while also ensuring that it is completed in time for autumn grass growing.

For safety and security reasons the site will be fenced off, probably from late July until spring 2012. The pedestrian pathway that runs between the present cricket grounds and the Lady's Acre will be restored on completion of the works, although to a slightly different layout.
